## Worldwide Limited Warranty

### Rotate Your Mattress To Assure Equalized Contour Comfort

Body impressions are a good indicator of contour comfort. **Your new sleep set may reveal body impressions up to 1 1/2" . This is normal and not a structural defect.** When they occur, this means that Therapedic Comfortized Mattress construction is conforming to your body's personal individual contours...and leveling to its final position.









- Insist on a genuine Therapedic foundation. It is designed to support the special construction in your Therapedic mattress. Turn the foundation end to end occasionally for maximum service and support.
- **Queen and King size bedding require a metal bedframe with an additional center rail with leg support.**
- Never bend or fold your Therapedic mattress, unless the King size model is designed as foldable.
- Always keep your bedding clean. **(The warranty shall not apply if bedding has been burned, soiled, is in unsanitary condition, or otherwise abused or damaged.)**  
A mattress pad is recommended, especially if children use your bed.

Regular **rotation** of a **one-sided** mattress will help minimize body impressions (see "Mattress Turning Schedule", Rotations #1 & #3). **Two-Sided Mattress:** Regular **rotation and flipping** of a **two-sided** mattress will help minimize body impressions (see "Mattress Turning Schedule", Rotations #1, #2 & #3).

#### MATTRESS TURNING SCHEDULE

**First 3 Months - Turn Mattress Every Two Weeks. After 3 Months - Turn Mattress Every Month.**

## Worldwide Limited Warranty

Your THER•A•PEDIC mattress and matching foundation have been engineered to work in concert to provide the finest sleep system available. Therefore, when purchased in a set, mattress and/or foundation warranty is for the number of years shown on the Limited Warranty Guide in this folder. To find your specific warranty, consult the code shown on the Law Tag affixed to your new THER•A•PEDIC mattress.

1. Your THER•A•PEDIC mattress will be replaced or repaired without charge, at THER•A•PEDIC's option, should your mattress be defective because of faulty workmanship or structural defects, during the initial period of warranty (other than specific limitations contained herein). Body impressions are caused by the natural compressions of quality upholstery materials, and are **not** structural defects. See Limited Warranty Guide for full information. Thereafter, the replacement or repair will be made at a pro rata charge of the current manufacturer's suggested retail price, times the number of years used (See Limited Warranty Guide).

2. Warranty shall not apply if foundation is not supported by an additional center rail with leg support frame, on Queen or King size.

3. Warranty shall not apply if bedding has been burned, soiled, is in unsanitary condition, or otherwise abused or damaged; and it shall not apply to border wires which are bent due to moving the sleep set.

4. If mattress is purchased separately, the use of an improper foundation may lead to abuse and the damage is not covered by the terms of this warranty. A THER•A•PEDIC matching foundation, or equivalent, is required for proper support.

5. Warranty shall not apply if Law Tag is removed.

6. Your THER•A•PEDIC Limited Warranty is valid only to the original purchaser.

7. If identical materials are not available at time of repair, Therapedic reserves the right to substitute materials of equal or better quality.

8. Because of the nature of the product, the mattress fabric is excluded from this Limited Warranty.

9. All transportation costs are the responsibility of the purchaser.

10. Service and handling charges will apply.

11. Purchaser is required under this Limited Warranty to return the Warranty Registration Card to the manufacturer at time of purchase.

12. In the unlikely event you observe a defect, you should contact the retailer from whom you purchased this product. If the retailer cannot be contacted, you should write directly to the THER•A•PEDIC manufacturer. In either case, you must provide proof of date and place of purchase.

13. This Limited Warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
